

1. Introduction

1.1 Our business

We supply water and sewerage services in an area with a population of 2.9 million customers, covering around 10,000 km².

Figure 1-1: Our business



Historically, we installed all the pipes required to supply new housing developments with water and sewerage services. While we still need to undertake some work to ensure new connections are safe and meet certain industry standards, customers can now choose who connects their new development to our water and sewerage networks. Water Supply Licensees (retailers for businesses) can also request that we provide new connection services on behalf of their customers.

1.2 Scope of our charging arrangements

These charging arrangements fix charges for services provided to those developing land and laying new water and sewerage infrastructure for residential and commercial purposes. Water, sewerage and trade effluent primary and non-primary charges to residential and commercial premises are fixed under separate charges schemes. These charging

arrangements set out in a single document our charges for the charging year (from 1 April 2025 until 31 March 2026). These charging arrangements replace all earlier versions.

1.3 Payment

Payment is on request, as per the standard payment terms detailed on the invoice, quote or offer letter. Please see the guidance notes for each activity.

1.4 VAT

All charges shown throughout this document are exclusive of Value Added Tax (VAT). We will add VAT, if applicable, at the appropriate rate to our charges.

The VAT rules are complex and primarily depend on the nature of the work undertaken and the type of property concerned. It is therefore not possible for us to set out the VAT liability for each item. Certain items included in this document will be treated as outside the scope of VAT, charged at either 0%, a reduced rate (currently 5%) or a standard rate of VAT (currently 20%).

For example, if you are constructing a new housing estate and require us to install a new water main that will be used solely to connect new dwellings, our charges will be zero rated for VAT purposes. In contrast, our charges to install a new water main connecting existing or commercial properties will be subject to VAT at the standard rate (currently 20%). Should the work be carried out as part of a property renovation or conversion for residential use, then VAT is likely to be charged at the reduced rate (currently 5%). Please contact us should you require further information.

1.5 Complaints and disputes relating to standards of services

1.5.1 Escalation of your complaint

We hope we can resolve your complaint without the need for it to be escalated. We recognise, however, that you might not be happy with the way that we have resolved your complaint or the time taken to resolve it. If you are unhappy with our response, you can write to our Managing Director at the address given above.

1.5.2 Disputes relating to self-lay agreements

If your complaint relates to a self-lay agreement, you should direct your dispute in the first instance to our Head of Developer Services at the above address. If a resolution is not forthcoming, and with the agreement of both parties, the dispute should be referred to mediation in accordance with the Centre for Effective Dispute Resolution (CEDR) Model Mediation Procedure.

If the parties do not agree to mediation, the dispute shall be referred to the decision of a single arbitrator mutually agreed upon or, failing such agreement, to be appointed by the president of the Chartered Institute of Arbitrators.

1.5.3 Complaints to Ofwat

You may, however, want to complain to Ofwat about the service or charges you have received from us, or if you feel that we are in breach of the Water Industry Act 1991 or the Competition Act 1998. Ofwat's address is given below.

1.5.4 Role of CCW

The Consumer Council for Water (CCW) is the representative for water and sewerage customers in England and Wales. It operates the Water Redress Scheme (WATRS) that covers some complaints about the connection charges regime.

CCW can consider complaints concerning administration, policies or process, as well as answer queries and provide advice about the connection charges regime. If a customer remains unhappy, they are able to refer their complaints to WATRS.

2. Our charging arrangements - an overview

2.1 What will you need to pay to connect to our network?

Each development will have its own requirements and the cost to connect to our network will vary by site. With this in mind, we have set out our charges in a way that allows you to estimate what services you require and what costs you need to pay.

The simplest development might mean a single connection to our water mains: this would mean that you would pay only a water connection charge and an infrastructure charge, which is your contribution towards the network reinforcement required to ensure we continue to deliver excellent services to all customers. The most complex development might require a large number of properties to be connected to new water mains and new public sewers: a customer would therefore need to pay connection charges (water and sewerage), infrastructure charges (water and sewerage) and, if we were carrying out the work, requisition charges (water and sewerage).

Each of the services we offer are set out in this document, in the following sections.

2.1.1 Non-contestable and contestable works

Each of the tables sets out our charge for undertaking the service provided.

- Some work needs to be undertaken by us: it is non-contestable and we need to undertake this work to meet our statutory obligations – you cannot let anyone else do this work for you.
- Other work is contestable: this is work that you can get a WIRS accredited contractor to do. Our charges set out the price we would charge if we were to complete that work.

We have made clear in this document which work is non-contestable and which is contestable. For contestable aspects, you can ask us to undertake all the work required, or you can obtain estimates from other accredited providers for the work required. So long as you know what services you require, the tables will help you understand what charges you will incur in making the connection to your new development. You will need to estimate what works you require and we will need to review this before we can confirm what your final charges will be. Your charges based on the scope of the work defined at the time of the quotation shall remain fixed for the duration of the quotation we provide to you. However where the scope of work changes

due to a change in your requirements or obligation or constraints by third parties we reserve the right to recalculate your charges based on the change in scope required.

We have created a spreadsheet calculator displaying our fixed up-front costs to aid estimation of the total charges payable, available on our website.

We recognise that you may need help understanding what works you require. We are happy to help and can arrange a site visit so that we can assess what you need to make the connection to your new development.

2.1.2 How have these charges been calculated?

Changes introduced by the Water Act 2014 have allowed Ofwat to move away from the legislative charging framework to a more flexible charging rules-based framework. Ofwat's rules reflect guidance from Defra, which set out five overarching objectives, being:

- stable and predictable charges;
- transparent and customer-focused charging;
- fairness and affordability;
- environmental protection; and
- · cost reflective of the relevant service.

We have developed charges that, we believe, are customer-focused. They comply with the requirements of Ofwat's rules and we have endeavoured to make them more transparent so that customers are clear what they are actually paying for and where they can choose an alternative provider.

We developed our charges following customer research, engagement and consultation. We also asked economic consultants to review these charging arrangements and the underlying models to ensure that we are compliant with Ofwat's rules and consistent with competition law. Our technical auditor has reviewed the data and methodologies used to set our charges.

Our charges are set to recover costs that we reasonably incur. The charges we set are based on assessments of labour, plant and materials required to complete each activity, using times and costs from observed data.

2.1.3 Non-household customers

Since April 2017, businesses and other commercial customers have been able to choose their water and sewerage retailer. If you are a business, you can request any of the activities contained in this document from your retailer. Alternatively, you can contact us directly to carry out the work or contact a self-lay provider to complete the work on your behalf.

These charging arrangements are only applicable in respect of the provision of services to household and non-household premises using water for domestic purposes only.

Where such premises require additional flows for non domestic purposes the charges for providing the additional services shall be charged on a site specific bespoke basis.

Water for domestic purposes refers to water used at the premises for drinking, washing, cooking, central heating and sanitary purposes as defined in section 218 of the Water Industry Act 1991.

2.1.4 What will I actually need to pay?

You only need to pay for the services that you choose to procure from us, or that only we can provide. Some development sites will require additional services, for example provision of hydrants (covered in our Wholesale Charges) or where there are environmental concerns and regulations to overcome. These costs will vary by site and circumstance and are not included in these charging arrangements: we will charge for these on the basis of costs actually incurred.

2.1.5 Connecting to our water and sewerage networks





Figure 2-2 Public sewer network

Figure 2-1 and Figure 2-2 show, schematically, where each of the charges might apply.

- Connection charges¹ are payable for on-site works to connect new properties to our network (within the dark green area).
- Requisition charges¹ are payable for works to build new mains or sewers required to support new development.
- Infrastructure charges are payable for network reinforcement required as a result of new development (within the light green area).

Works required within the pink area are not linked to new development, and new connection services' customers are not required to pay for these.

Figure 2-1 The water network

2.1.6 Site Specific charge cap

Where we wish to specify a point of connection which is different from the nearest practical point, or we reach an agreement with the applicant on an alternative point of connection, the charge for site specific work will be capped. The cap will be equal to the lowest of the site specific charges that would otherwise be applicable if connecting at the nearest practical point on the existing network where the connecting pipework is of a no larger nominal bore than that of our existing network.

2.1.7 Exceptions to providing upfront requisition and diversion charges

We offer fixed upfront charges for water supply and wastewater requisitions and diversions where the works involved are simple in nature. That is, we have reasonable knowledge and understanding of the costs, potential risks and external factors that could affect the scheme.

We reserve the right to seek further costs from you should there be any change of scope, change in information provided to us or any other change that results in it not being reasonable for us to carry out the requisition or diversion on the basis of a fixed upfront charge.

Water supply requisitions and water main diversions

Where you requisition a water supply main or request a water supply main diversion (under sections 41 or 185 of the Water Industry Act 1991) we will offer you a price for the scheme based on the fixed charges set out in these charging arrangements if it is reasonable for us to do so.

Where the included works are affected by external factors outside our control, are subject to known or unknown site specific risks and uncertainties or involve a degree of complexity in delivering the scheme which would make it unreasonable for us to provide an upfront charge we will provide you with a high-level bespoke estimate.

The high-level bespoke estimate will be designed to fairly recover the costs incurred in delivering the scheme. It will consist of a brief description of the works involved and a site specific budget price estimate for the whole scheme, taking into account the level of detail and information available to us at the time.

Should you decide to proceed with the scheme, based on the bespoke estimate, it will be delivered on a rechargeable basis with any savings achieved returned to you and any additional costs incurred payable by you.

Instances where you will be offered a bespoke price estimate include, but are not limited to:

- Laying of water mains:
 - o 300mm or greater in diameter; or
 - o involving valve complexes; or
 - o requiring a shut down or supply interruption to sensitive organisations or a significant number of customers.
- Where entry to lay or access to the pipe is required through:

- land in multiple ownership or occupation;
- o land designated or planned for premium use;
- o land subject to protracted negotiation or dispute; and
- land owned by a protected undertaker (e.g. land owned by Network Rail or the Crown, rivers or motorways).
- Where laying the main would involve crossing a river or motorway.
- Where we are unable to serve statutory notice for the works or require the consent of a 'protected undertaker'. E.g. crossing land owned by Network Rail, the Ministry of Justice, the Ministry of Defence or the Crown.
- Where ground conditions are particularly difficult (e.g. excavation of rock or artificially hard material) or require temporary or specialist works.
- Where the work to be carried out is close to or in land with particular environmental, historical or archaeological characteristics or in a flood plain.
- Where services or other utility assets (including our own) are discovered or known to be located in close proximity.
- Where the works involved are subject to third party or consenting authority restrictions, constraints or refusals (such as night working);
- Where road closures affect major junctions or where high speed traffic management is required.

There may be occasions where providing an indicative estimate is not possible or where the estimate will not meet the degree of confidence desired by you. In such cases, we will discuss with you the best way to proceed including the possibility of using the stage gate process (see section 2.1.8).

Wastewater requisitions and sewer diversions

Where you apply to requisition a sewer or request a sewer diversion from us (under sections 98 or 185 of the Water Industry Act 1991) we will offer you a price for the scheme based on the fixed charges set out in these charging arrangements if the construction work required is simple.

That is:

- The total length of sewer (gravity and pumped) is less than 100m in length.
- Any gravity sewer is no more than 300mm in diameter or deeper than 3m.
- Any pumped sewer is no more than 80mm in diameter or deeper than 1.5m.
- The ground conditions require no temporary or specialist works.
- All waste excavated is classified as inert.
- Where entry to lay or access the pipe is through land that:
 - o Is owned and occupied by a single legal interest;
 - o Is scrubland, moorland or bare agricultural land which is pasture or arable; and
 - Has no development premium hope value.
- Where we are able to serve statutory notice for the works and do not require the consent of a 'protected undertaker'.

Where the included works are affected by external factors outside our control, are subject to known and unknown site specific risks and uncertainties or involve a degree of complexity in

delivering the scheme which would make it unreasonable for us to provide you with an upfront charge, we have set out in section 2.1.8 our stage gate process.

Examples of where our stage gate process shall apply include, but are not limited to:

- The laying of sewers involving any of:
 - pumping stations or treatment works;
 - the disposal of waste other than inert;
 - o the location and diversion of other services;
 - work where ground conditions are particularly difficult (e.g. excavation of rock or artificially hard material) or require temporary or specialist works;
 - over pumping of existing flows;
 - dewatering of ground water;
 - o the provision of site security;
 - work where the construction period is greater than 12 months;
 - work with restricted access;
 - work with constraints such as night working or other restrictions;
 - work being carried out close to or in land with environmental, historical or archaeological characteristics or in a flood plain;
 - where road closures affect major junctions or where high speed traffic management is required;
 - where entry to lay or access the pipe is required through:
 - land in multiple ownership or occupation;
 - land consisting of residential or non-residential gardens and amenity use:
 - land consisting of woodland, market gardens, allotments or a specialist agricultural use;
 - land designated or planned for premium use; and
 - land subject to protracted negotiation or dispute.
 - where laying the sewer would involve crossing a river or motorway;
 - where we are unable to serve statutory notice for the works or require the consent of a 'protected undertaker'. E.g. crossing land owned by Network Rail, the Ministry of Justice, the Ministry of Defence or the Crown.

In the first instance, the stage gate process provides you with a high-level feasibility assessment and budget price estimate. Should you decide to proceed with the scheme it will be delivered on a rechargeable basis with any savings achieved returned to you and any additional costs incurred payable by you.

Our stage gate process provides you with the opportunity to understand and control your phasing of spend on the project and only requires you to pay up front the costs for the next stage of the project.

2.1.8 Stage Gate Process

Our stage gate process is subject to contract and is designed to offer a fully rechargeable site specific bespoke solution. To proceed we will ask for a deposit against the full cost of the scheme that will be refundable in part if you at any point you decide not to proceed. The

deposit is calculated at £2k, £5k and £10k for small, medium and large site works respectively. For very large, complicated or unusual sites a bespoke deposit will be discussed and explained to you.

A primary advantage of our stage gate process is the improved cash flow of this solution over full upfront charges.

The stage gate process provides you with a better understanding of the phasing and progression of the project. You are only required to pay for the next stage of the project before it commences. You will be given early warning of any risks that may affect the outturn costs of the project and there is a settlement charge or a refund at the end of the scheme which means you only pay what the project costs to deliver.




Figure 2-3 - stage gate process

2.2 Income offset

In December 2024, Ofwat published updated "<u>Charging rules for new connection services</u>" confirming that from April 2025, they are prohibiting companies from offering income offset under or in connection with any agreement entered into from 1 April 2025. This means the rule to maintain the balance of charges has also been removed. Wessex Water's policy, since April 2024, is that any connections made or paid for after 1 April 2025 will not include any income offset reduction².

The income offset arrangement was previously applied to infrastructure charges in accordance with regulatory requirements and meant that our other customers contributed towards the costs of improvements to our existing network required to serve new development. The removal of income offset provisions means that new connection services' customers pay the full cost of new development with no contribution made by existing customers.

Further details on infrastructure charges are set out in Section 8 of these arrangements.

² For schemes accepted before 1 April 2024, income offset is applied according to the terms of our charging arrangements in the applicable year. Please see the relevant charging arrangements on our website for further details.

2.3 Transitional arrangements

These Charging Arrangements come into effect from 1 April 2025.

2.3.1 Introduction

Although the new charging rules come into effect for work quoted on or after 1 April 2025, we recognise that some work will be quoted prior to this date. These quotes would have been drawn up using previous Charging Arrangements. We will use the following rules to determine whether the 2024-25 or 2025-26 charging arrangements apply:

2.3.1.1 Quotes issued prior to 1 April 2025

Before 1 April 2025, for all quotes issued under the 2024/25 Charging Arrangements:

- a) If your work has commenced, you cannot ask for a re-quote under the 2025/26 arrangements.
- b) If your work has not commenced, you can ask for a re-quote under the 2025/26 arrangements after 1 April 2025. Please note that the relevant application or administration fees will apply.

To confirm if your existing quote is still valid, please refer to section 2.4 below.

2.3.1.2 Quotes issued on or after 1 April 2025

For work quoted for and commencing on or after 1 April 2025, the charges in these Charging Arrangements will apply.

2.3.1.3 Re-quotes on or after 1 April 2025

If a developer accepts and pays a quote issued under 2024/25 Charging Arrangements but work has not commenced, and then requires a re-quote on or after 1 April 2025, the 2025/26 Charging Arrangements will be used to calculate the re-quote.

If an SLP/Developer has an active adoption agreement that was issued under the 2024/25 charging arrangements and then requires a Significant Variation on or after 1st April 2025, the 2025/26 charging arrangements will be used as the new basis for the agreement. (See section 19.2 of the Water Adoption Agreement).

If customers ask for a requote at any time, we will apply the relevant fees.

For more information on how long your re-quote will be valid for, please refer to section 2.4 below.

2.3.2 Legal Agreements

Where a legal agreement is already in place, then the charges within that agreement remain valid for the life of the agreement, unless we agree to vary those charges with you.

2.3.3 Inflation

Charges relating to former charging rules or a previous year's charging arrangements, will be adjusted by inflation if the quotation or legal agreement includes an appropriate provision for adjusting the charges.

2.3.4 Infrastructure Charges

The value to be paid will be that set out in the charging arrangements that were in force at the time of your quote or offer letter, if you accept (pay) that quote or offer letter in

accordance with the validity terms laid out in section 2.4. We reserve the right to make adjustments for inflation where there is a time lag between your quote or offer letter and commencement of the works that falls outside the validity terms.

2.4 Validity of Quotations

A summary of our quotation validity for our suite of charges is presented below. Please see the relevant sections for a detailed description of our charges.

2.5 Statement of Significant Changes

2.5.1 Introduction

Where new connection charges for typical developments are set to increase by more than 10% from the previous year, we are required to publish a Statement of Significant Changes setting out: what size increase is expected; what types of typical developments are likely to be affected; and associated handling strategies.

This year's connection charges are increasing, resulting in bill incidence effects for over 10% for the worked example scenarios set out in Ofwat's *Common Terms and Worked Examples* – *English New connection Rules*. The main factors driving this increase are:

- 1. A planned increase in infrastructure charges, reflecting our approach to setting these charges to recover forecast network reinforcement over a five-year time horizon according to smoothed profile of increases.
- 2. The removal of the income offset, which Ofwat has said should not be applied for any connection entered into from April 2025. This further increases the (net) infrastructure charge to be paid.
- 3. An increase in labour time & materials required for certain jobs, following an internal review of the time and full set of activities that is undertaken to deliver recent new connections. This is required to ensure that we recover the full costs of provision going forwards, and that our charges remain cost reflective.
- 4. An increase in traffic management costs, partly resulting from increases in third-party charges.
- 5. The ongoing impact of inflation, which, while not as high as in previous years, remains forecast to be above the Bank of England target.
- 6. The government's announcement of increased National Insurance payments from 6 April 2025.

We have therefore prepared a Statement of Significant Change for our 2025-26 new connection charges, which is published on our website alongside these charging arrangements³.

The Board of Directors has assessed the effects of the new charges on customers' bills for the scenarios set out in Ofwat's worked example scenarios, and it has approved the impact assessments and handling strategies developed in response to this. This is also included in our full Statement of Significant Change.

A summary of year-on-year charges is included in the tables in Section 2.5.2 below. Where our current year scenarios have been updated to reflect best practice, we have adjusted the previous comparison year to compare like-with-like.

2.5.2 Analysis of bills for typical developments

We based our scenarios on the latest scenarios provided by Ofwat's *Common Terms and Worked Examples – English New Connection Rules*, updated most recently in December 2024⁴. However, we note the following:


- Wastewater connection costs are not included as, in most cases, this work is not undertaken by Wessex Water. However, we reserve the right to make the connection ourselves under S107 of the Water Industry Act 1991 and different charges would therefore be applicable.
- Wessex Water has the policy of only using barrier pipes in our service connections and our charges reflect this.
- We charge a single Application and Adminstration fee inclusive of all relevant costs.
- As income offset is no longer applicable, we have removed the comparable figure in the 2024-25 charges. Consistent with Ofwat's latest guidance, we have also assumed that the environmental incentives for water and sewerage have both been earned⁵. This allows us to present a more like-for-like comparison between years.

Our scenarios are set out in full in Appendix B to these arrangements, using Ofwat's formatted tables.

Using our published cost calculator template, each scenario can also be found on <u>our website</u> with the detailed build-up of relevant charges. A summary of the scenarios are displayed in the following tables (figures may not add up due to rounding):






Scenario 1a: Single connection to four properties from an existing main,





3. Applying for a new connection

3.1 Connecting your property to our network

The type of connection you require could vary depending on the number of properties you are connecting and the distance between your development and our network. Technical guidance is set out in separate documents, which should be read in conjunction with these charging arrangements.

- For connections to our water network, you can choose to have your new service connections and water mains (if required) laid by us or an accredited third party (or self-lay provider). Some work will need to be undertaken by us, even if you choose an accredited third party, so you will need to tell us about progress of work on the site.
- For connections to our sewerage network, you can choose to have your connections and sewers laid by us or by a suitably qualified third party. Should you use a third party to lay sewerage pipes, once the pipes are laid to a satisfactory standard, you can ask us to adopt your pipes if they have been constructed to the appropriate standard (see technical guidance). Adoption means that ownership of the pipes transfers to us and we take over responsibility for maintenance.

Another alternative is for you to engage a New Appointment or Variation company (NAV) to supply new householders on your development with water and sewerage services (under a 'new appointment or variation'). The NAV may lay the pipes and other infrastructure required and buy bulk services (water and/or sewerage) from us. The NAV remains responsible for the newly laid infrastructure within the area of the development.

3.2 How do you apply for a new connection?

If you want to make a new connection to our network, you or your retailer will need to:

Complete an application form and:


- a) for water connections:
 - ensure you have obtained water regulations approval;
 - advise us that your trench and service pipe are ready to be inspected;
 - make payment; and
 - have works completed by Wessex Water or approved contractor
- b) for sewerage connections:
 - submit full drainage details;
 - advise on the point and method of connection to our system;
 - make payment; and
 - have works completed by Wessex Water or approved contractor.

3.3 How do you find out about our mains and sewers?

You may need to know where you can connect to our mains and sewers. Plans showing the approximate location of our water mains and sewers can be obtained either, online at https://maps.wessexwater.co.uk/webapps/request-a-map/, from our asset enquiries team

within Developer Services, or you can visit our offices and see these plans. Alternatively, plans showing the location of our sewers only can be viewed at local authority offices.

If a proposed development site is close to a water recycling centre and / or Sewage Pumping Station then, at pre-planning stage, odour modelling is required to take place. Where there is a need for you to understand if a development would have issues with odour, this charge ensures we have the resource in place to provide you with the assistance required.

If a proposed development site is close to a Water Recycling Centre, then, at pre-planning stage, a Fly Nuisance Risk Assessment may also be required to take place. Where there is a need for you to understand if a development is likely to have a fly nuisance issue, this charge ensures we have the resource in place to provide you with the assistance required.

Note: not all our sites pose a fly nuisance risk, please contact the Planning Liaison Team for confirmation as to whether the site close to your development is one that does.

3.4 Abortive and additional visits

The Table 3-2 charges will apply where we:

- arrange to visit a site and the site is not ready or we are not able to carry out the work as arranged; or
- are required to reinspect a site or additional visits are deemed necessary; or
- if a customer amends the commencement date, you will recharged for any costs we incur.

3.5 Working in the Road

The below table of charges reflect the increased use of working in the road activities and their costs across projects, in alignment with highway regulations to increase safety.

As the highway regulations are controlled and managed by a third party (The local Highways Authority), it won't always be possible for us to include all applicable traffic management charges at the time of your quote. Where this is the case, you will be invoiced separately for any additional items, or refunded where items are no longer required, as applicable.

Please visit your local highway authority's website for more details of their fees. Any terms and conditions they apply to their charges will be passed through to you where appropriate, for example: applying a Highway Permit, fees for cancellation, variations or rescheduling of permits. At the time of our publication, there are a range of permit fees: £0-£130 for up to 10 days work and for road closures: £74-£345 depending on the highway authority and the type of road.

Additionally for road closures, the council charges to apply a Temporary Traffic Restriction Order (TTRO). At the time of publication, examples are: Devon £865 and Bristol £2,177. Please visit your local highway authority website for further details and their terms and conditions which we will pass through to you.

If you need any assistance finding Highways or Council permit fees, please contact us.

Road Closure requirements are defined in the Safety at Street Works and Road Works (A Code of Practice) Red Book. Where you require an expedited acceleration of the approvals of a road closure, where applicable and permitted by the relevant Highways Authority, a separate charge will be invoiced as a pass-through cost (currently costs vary to approx £1000). In such cases, the timing of the approval of the road closure remains at the discretion of the Highways department and is not guaranteed.

4. New water supply connections (s45)


4.1 Do you need to connect to our supply network?

If you want mains water for domestic purposes in your new development, you will need to connect to our water supply network. This means that you (or your contractor) will need to lay a private service pipe that can be connected, at your expense, to the nearest suitable water main. If your development requires water supplied for non-domestic purposes, please contact us separately to discuss.

A single house may require a small diameter water pipe laid from an existing main to the boundary of the property where a meter chamber and stop-tap (valve) is normally located. This is known as a service connection and this section of pipe is referred to as the communication pipe. A small diameter private supply pipe within the boundary of the property links the communication pipe with the internal plumbing of the house.

To ensure you have access to potable water, you will need to make a new water supply connection between your new development and our water network. Figure 4-1 will help you understand whether you need a new supply connection.

4.2 Who can connect your property to our water supply network?

We can connect your new development to our network and undertake all the works required. To protect our network and our customers, some work, described as non-contestable, can only be undertaken by us, whereas contestable work can be undertaken by you, your contractor or an accredited third party/self-lay provider.

4.3 Our charges - connecting to our water supply network

Each new (water) connection includes the installation of a meter box, meter and 2m (linear) pipe-laying, excavation and reinstatement. Our charges reflect the costs we incur, including those we pass on from third parties, such as local councils' traffic management fees.

Where we don't have the statutory power to access the land or there is a requirement to cross a motorway, railway or watercourse, additional charges may apply. Please contact us to discuss your needs in such circumstances.

If you need to install fire hydrants for new builds, charges for these activities are found in our wholesale charges scheme, published on our website. Where there is a requirement for installing fire hydrants by the fire brigade, the costs we incur will be borne by the fire and rescue authority concerned.

We recognise that you may need help understanding what works you require. We are happy to help and can arrange a site visit so that we can assess what you need to make the connection to your new development.

4.3.1 What charges are payable?

Table 4-1 sets out the non-contestable administration charges for different elements of work required to make a connection to our mains.

Table 4-2 shows our charges if we undertake the contestable works you require. Contestable works are those that can be done by another provider so you might want to compare our charges with a firm quotation from another provider. As summarised in 2.4, our quotations are valid for the longer of a minimum 3 month period or to the end of the financial year and after that you will need to re-apply. Once you have paid, our quotation is guaranteed for a further 3 months.

Smart Meters

We are focusing on opportunities to reduce water usage and our policy of rolling out smart water meters is being introduced from 2025. The first five years of our smart metering rollout will focus on the east of the Wessex Water supply area. There is a precious chalk stream river system in this area, and the more we can help customers reduce water use, the less we need to take out of the aquifers and rivers to the benefit of the watercourses and the nature they support.

If your development is in a rollout location planned for this or the next financial year, all new connections will now need to install smart meters and an additional Smart Enabling Fee will be applicable to connection charges. This fee is set out in Table 4-2.

Out of hours working

In certain circumstances the Local Highways Authority will require that works in the street be carried out overnight. This unfortunately comes at an extra cost for your development. In cases where we are made aware of the requirement (for overnight works) at an early stage, we will make sure to include this charge when we issue you with your quotation. However, as this element of the process is not within our control, there may be cases where we are only made aware at a later date. In such cases, you will be invoiced separately to cover the additional costs that we incur. The new charge is included in Table 4-2.

4.4 Disconnection charges

If you decide you no longer require a water supply, you will need to apply for a temporary or permanent disconnection. Where a temporary disconnection is required, these charges are set out in our household and wholesale charges schemes.

No charges are made for a permanent disconnection from the mains water supply for domestic properties: we will make the disconnection at the point of connection to the main and not at the service end of the pipe to ensure the work is carried out correctly and we do not end up with any 'dead legs' (a length of pipe that water does not move through). We consider it appropriate that we cover this cost to reduce potential problems in our network. However, customers looking to remove multiple properties/connections from our network will be charged under a non-standard S185 (water mains diversion) due to the bespoke nature of the works.

4.5 Frequently asked questions

Frequently asked questions	
Can I connect to an existing private service pipe?	No – a separate connection is required direct from our public water mains.

Can I lay my pipe in the same trench as other utilities?	Yes – provided adequate clearance is provided between the water pipe and other utilities. Please see National Joint Utilities Group (NJUG) guidelines for requirements.
Where will my water meter be located?	Normally, the meter will be located at the boundary of your property or if your property is a flat, your meter may be located internally.
What are water regulation fittings?	These are national requirements for the design, installation and maintenance of the internal water fittings (i.e., heating system, sinks, WCs etc). Their purpose is to prevent inefficient use of water and to prevent contamination.

5. Water mains requisitions (s41), adoptions (s51) and diversions (s185)

5.1 Do you need to lay (or divert) a new mains?

While some new developments may make use of private water sources, most developers need to be sure that all new properties on their new development can be supplied with mains water. This may require a new water main to be built to ensure there is sufficient water, at sufficient pressure to meet the expectations of new households living in the new development.

While all new developments require a service connection, not all new developments require a new mains. The diagram below is intended to help you understand whether you require a new water mains.




Figure 5-1 New mains connection

Section 4 sets out the charges for new service connections.

If an existing water main crosses a new development site, we would prefer the layout to be designed in such a way that it avoids the new mains, with agreed clearance. If this is not possible, the main can be diverted before any building works start.

We use barrier pipe unless you provide a soils report to prove that whole site is free of contamination and confirmation that no permeable paving will be included on the site.

5.2 Who can lay (or divert) new mains and make the connections?

Where new mains need to be laid (or diverted) this must be carried out in accordance with the National Joint Utilities Group (NJUG) guidelines on the positioning and colour coding of utilities apparatus, in order to safeguard the health and safety of our staff and to ensure that our apparatus remains accessible for future maintenance. So long as these guidelines are followed, you or your accredited third party contractor (SLP/NAV) can lay (or divert) the new mains, or you can ask us to do the work for you.

Mains are pressurised and carry large volumes of water so building near or over them is not permitted as it could lead to premature failure with potential risk to life and property or contamination risk.

A water main cannot be laid within the curtilage or enclosed gardens of any newly developed property as this could prevent accessibility for repairs and maintenance. We have legal rights and powers to protect and ensure access to our assets. If you have any doubts or concerns in this regard you should contact us.

5.2.1 Non-contestable work that only we can undertake

We retain responsibility for certain work for reasons of network security and public health. We will undertake this work and where appropriate, we will make a charge to recover our reasonable costs.

A developer can requisition us to lay mains pipes and other necessary works (which might include a service reservoir or booster station), in accordance with the arrangements set out in the Water Industry Act 1991.

5.2.2 Contestable work that any accredited provider can undertake

An WIRS (Water Industry Registration Scheme) Accredited Third Party may install water mains and make service connections subject to an adoption agreement being in place. Accreditation is required to satisfy us in advance of technical competence and experience of main-laying to safeguard public health and the integrity of our supply network.

More information about the WIRS accreditation process can be found by visiting WIRS (www.lrqa.com).

5.3 Our charges – laying (or diverting) a new mains

In this section, we set out our charges for laying new water mains for your development. Our quotations are valid for 6 months. After this point if you wish to continue with the works you must request a review of that quotation. However once the quotation for a requisition is paid, it is guaranteed for a further 6 months from payment date.

For complex engineering projects where you requisition us to do the work (under section 41 of the Water Industry Act 1991), or if the works covers water mains of strategic importance, the upfront charges set out in these charging arrangements may not be available to you. Complex projects might include those where the project needs to cross railway tracks, motorways or rivers, or where the ground conditions are particularly difficult. Section 2.1.7 outlines these exceptions in further detail.

The costs and complexities of such projects mean that it would be unreasonable to expect that this work is priced on the basis of upfront fixed costs.

5.3.1 What charges are payable?

Table 5-1 and Table 5-2 show our charges for non-contestable and contestable work.

We realise you may need help understanding what works you require so on receipt of an application and the application payment we are happy, if required, to arrange a site visit with an engineer so that we can assess what you need to make the connection to your new development.

If you need to install fire hydrants for new builds, charges for these activities are found in the Wholesale Charges document, published on our website. Where there is a requirement for installing fire hydrants by the fire brigade, the costs we incur will be borne by the fire and rescue authority concerned. Due to the scope of work and individual needs for all fire suppression requirements, each enquiry is evaluated on its own merits and a bespoke quotation for the works will be issued.

5.4 New appointments and variations (NAVs)

Where your development is to be served by a NAV, the NAV will own the mains and will take on responsibility for the assets. NAVs connecting to our network will need to purchase bulk supply and discharge services as required to serve the development and they will find information on their charges from us on our website.

5.5 Our charges – adoption of assets

Mains built by the developer/ WIRS Accredited Third Party will, subject to satisfactory design and installation, become part of our network and we will take over responsibility for those assets. Service pipes will not be adopted by us apart from any length up to and including the meter. This will usually be the pipework which falls within a street, known as the communication pipe.

5.5.1 Fees and deposit payable for vesting of mains assets

Where we adopt mains, we charge fees for service as shown in Table 5-3 and Table 5-4. Quotations provided are valid for 6 months and, once paid, the quotation is guaranteed for a further 12 months from payment date. Our legal agreement will automatically terminate if no works have started after 24 months.

Meter details need to be provided to us 1 day after connection for commercial connections and within 5 days for domestic connections. Where we incur a late notification fee we will pass this charge onto the SLP and is included in Table 5-3. Please refer to the water sector guidance⁶.

5.5.2 Ownership, operation and maintenance of the new mains

Ownership, operation and maintenance of the water mains rest with the customer until a vesting certificate is issued by us. Ownership, operation and maintenance of the service connection and communication pipe rests with us from the time of connection to the new main. The developer/NAV/SLP remains responsible for any defective materials and workmanship for an agreed Defects Liability Period (DLP).

5.6 Our charges – diversion of existing mains

If existing water mains cross a new development site and the layout cannot be designed to avoid them, they must be diverted if technically possible. You can propose a scheme and ask us to consider whether a diversion is possible.

5.6.1 What charges are payable?

For diversion of water mains up to but not including 300mm diameter, any Accredited Third Party provider can undertake the diversion work for you since this work is contestable, but they will not be able to undertake non-contestable elements (such as work on our live assets) and those charges will continue to be applicable.

For complex engineering projects where you requisition us to do the work or if the work covers water mains of strategic importance, the upfront charges set out in these charging arrangements may not be available to you. Section 2.1.7 outlines this in further detail and section 2.1.8 outlines the stage gate process we would use in these instances.

The appraisal & design fee covers our costs of determining how best to divert the mains, which may require us to undertake a detailed assessment of works required. If the work is not undertaken but we have incurred costs, we will refund part of the fee. Table 5-5 sets out our charges.

6. New sewer connections (s106/s107)

6.1 Do you need to connect to our sewer network?

To ensure you can discharge your sewage into our sewer network, you will need to make a new sewerage connection between your new development and our sewerage network. If you require a new connection direct to a public sewer then you will need to apply to us for formal consent. You do not need to apply for connections to private soakaways, cess pits, septic tanks, treatment works or similar.

6.1.1 What connection do you need to make?

To connect to a public sewer you will either require a junction/saddle connection or you will make your connection via an existing or newly built manhole. Up to three dwellings can be connected to a Y or saddle junction; more than three dwellings must be connected via a new or existing manhole. More information can be found in our technical guidance documents.

6.2 Who can connect your property to our sewer network?

Depending on what type of connection you need to make, the work required may be contestable or non-contestable. Section 6.1.1 provides more detail on what type of connection is required in your circumstances.

6.2.1 Non-contestable works (connection via a Y junction or saddle)

Connections made to our sewer network by means of a Y junction or saddle connection will generally be non-contestable under section 107.

6.2.2 Contestable works (connection via a manhole)

Connections made to our network through an existing or new manhole are contestable work, which may be carried out by a suitably qualified contractor holding a Wessex Water permit card to work on sewers. Our technical guidance documents set out more information about accreditation.

6.3 Our charges – connecting to our sewer network

Table 6-1 sets out our charges. We do not undertake work on building sites to lay pipes for sewerage connections.

The inspection fee covers up to two visits. All works must be carried out in accordance with the current edition of Water UK's Design and Construction Guide.

6.4 Frequently asked questions

Frequently asked questions			
What if I need to make a pumped connection?	Pumped systems are more complex than gravity systems and can pose a risk to the public sewerage system, particularly with regards to septic waste. Where a private rising main will discharge into a public sewer then a 'break' manhole must be constructed at the end of the rising main, to allow the flow to gravitate to the public sewer.		
What is a lateral drain?	A lateral drain is a pipe that runs from the property boundary to connect to the public sewerage system. It is generally laid in third party land where land entry notice may need to be served, or in the highway. If necessary, Wessex Water can serve notice on third party landowners to allow a connection to be made. You can requisition a lateral drain from Wessex Water to serve a domestic property. This is a separate process to a connection application: more information is to be found in section 7.		
Can I make a connection to a private drain?	Indirect connections may be made to suitable existing private drains, with permission being obtained from the owner of that drain. Technical approval and the inspection of indirect connections will be carried out by Building Control, not by Wessex Water. They may only wish to attend or formally approve the work if it forms part of a new build or significant extension. You can employ any groundworker to complete the work with the agreement of Building Control or your private inspector. Please be aware that any foul waste/rainwater that you connect will ultimately discharge to a public sewer. In certain cases, particularly with larger developments or where a rainwater connection is being proposed, you need to obtain our approval for the resultant flows.		

7. Sewer requisitions (s98), adoptions (s102/s104) and diversions (s185)

7.1 Do you need to lay (or divert) a new public sewer?

If your proposed new development is not near an existing public sewer and/or you need to cross third party land to connect to our sewers, you can require ('requisition') us to lay a new public sewer from the nearest public sewer to the edge of the new development.

7.1.1 When can you requisition a new sewer?

Sewers are normally only requisitioned for domestic purposes to serve new development. The requisitioned sewer will be constructed by, or on behalf of Wessex Water. It is termed as a public sewer if it serves two or more properties, or a public lateral drain if it serves only one property.

Costs incurred in transferring or acquiring the freehold of land required for pumping stations or other sewerage assets will be included in the cost of the requisition.

Although legislation refers to requisitioning off-site sewers for domestic purposes, any commercial development containing an element of flows for domestic purposes, will be considered. Flows for non-domestic purposes may need trade effluent consent.

7.1.2 Who can requisition a new sewer?

Public sewers and lateral drains can be requisitioned by the owner or occupier of a property, or a developer, or the relevant local authority. You must have been granted full planning permission for a proposed development before sewer construction can start. If outline planning has been agreed, then appraisal can start while full planning is finalised.

To requisition a surface water sewer, you must have agreed formal discharge consent from the landowner of the watercourse where the outfall is to be located. Land ownership is the property alongside the watercourse. Without a discharge consent agreement in place, the sewer cannot be connected.

7.2 Who can lay (or divert) a new public sewer?

Subject to contract and at our sole discretion we may in some cases permit a requisitioner to design and construct at their cost a sewer or public lateral drain through third party land using our powers to construct the pipe under notice - A developer delivered requisition.

Under a developer delivered requisition we will serve statutory land entry notices but the full cost of the scheme including our costs in facilitating the developer delivered requisition and third-party compensation costs will be met by the requisitioner.

For the purposes of the Construction (Design and Management) Regulations 2015, under a developer delivered requisition contract the requisitioner will take on the role of client including the requirement to appoint the roles of principal contractor and principal designer as required.

For quality assurance purposes we reserve the right to comment on and approve the proposed design and contractor appointments. We will also inspect and test the works.

On completion of the works the requisitioner shall arrange a CCTV survey and production of as-constructed plans and levels.

The requisitioner shall ensure that all design and construction work is carried out by suitably qualified and experienced personnel and health and safety plans comply with our requirements for work on our sites and on our assets.

The requisitioner shall also be required to comply with our code of practice for the exercise of pipelaying powers on private land.

7.2.1 Non-contestable works

On some occasions, when a customer applies for a connection to our water supply or sewerage networks, or requisitions a new main or sewer, a check on the adequacy of our existing systems will need to be made.

7.2.2 Contestable works

Our technical guidance documents set out further details on developer delivered requisitions.

7.3 Our charges – laying (or diverting) a new public sewer

Where you requisition us to lay a new public sewer or lateral drain (under section 98 of the Water Industry Act 1991), the works involved are simple in nature and we have reasonable knowledge and understanding of the likely costs, potential risks and external factors that could affect the scheme outturn costs, the upfront charges set out below are available to you.

When the complexities of a requisition mean that it would be unreasonable to expect that this work is priced on the basis of upfront fixed charges, our stage gate process offers a fully rechargeable site specific bespoke solution and is set out below.

Section 2.1.7 outlines instances when the upfront charges or the stage gate process applies. Table 7-1 and Table 7-2 show our charges for non-contestable and contestable work where upfront charges apply. Our quotations are valid for 6 months and after that you will need to apply for a refresh if it is covered within the same charging year otherwise a full re-application will be required.

The charges in Table 7-2 provide for up to:

- 4 nr chamber on gravity sewers;
- 1 nr air valve, washout chamber and connection for pumped sewer option; and
- nominal sum for design.

If there is not enough detail in the table above to price your project, then it is likely your project does not meet the criteria to be priced using our upfront charges and you will need to apply for a requisition following our stage gate process. Further information is included in section 2.1.8.

7.4 New appointments and variations (NAVs)

Where your development is to be served by a NAV, the NAV will own the sewers and lateral drains and take on responsibility for the assets. NAVs connecting to our network will need to purchase bulk supply and discharge services as required to serve the development.

7.5 Our charges – adoption of assets

We levy administrative charges where we adopt assets, whether they are existing or new.

7.5.1 Existing private sewage treatment works and/or private sewers (s102)

We can adopt private sewerage systems under section 102 arrangements. The adoption process requires the party applying for adoption to carry out an as-constructed survey and a structural survey of the assets they want us to adopt. We will inspect the system and advise if any repairs are required. Once we agree that the assets meet an acceptable standard, we will serve formal notice on the current asset owners and interested parties. After two months, if no objections have been raised, we will vest the assets and confirm the system has been adopted as public.

Where we propose to adopt an existing private treatment plant under this process and a sampling history cannot be provided as part of the submission, we will be required to undertake sampling for a minimum period of 6 months to ensure compliance with discharge consents prior to adoption. Please see technical guidance for more information. With regard to sewer adoption, this means the ownership and responsibility of the asset is transferred to us. You must pay all inspection fees and the cost of any remedial works required to ensure the sewerage system is to an acceptable standard before the sewers are adopted.

7.5.2 New sewers and pumping stations (s104)

An adopted sewer is operated and maintained as a public asset by us. A private sewer is owned and maintained by the private owner or the local authority at their expense. Sewers constructed as part of a new development can be offered for adoption so that they are looked after by us in the future. Sewers and pumping stations need to be designed and built according to specifications in the latest version of Design and Construction Guidance. Adoption compliance fees cover the cost for us to confirm the asset is built to the requisite standard.

New pipes that only serve a single property and are entirely within that property's boundary will not be adopted and will remain the responsibility of the property owner. Adoption of new

sewerage systems under a section 104 agreement is a separate process to a connection application. New manhole chambers built on an existing public sewer will automatically become part of the public system on completion.

You can ask us to consider adopting a private sewage treatment works where it serves 10 or more properties and includes at least one length of sewer upstream. Table 7-4 shows our charges for contestable work.

The adoption compliance fee that will apply depends on the quoted construction cost and therefore one of the above fixed charges will apply. Each charge covers up to 2 inspections per month. If more inspections are required, these will be charged additionally (additional

inspection charges are included in Table 3-2. A flat fee is used for smaller sites, where inspection time is typically driven by size. For the biggest of sites (over £1m construction cost), a percentage is applied as inspection time is typically driven by the complexity of the site.

7.5.3 Sustainable Drainage Systems (SuDS)

We support SuDS which provide benefits of reduction in flood risk, improvement in water quality, biodiversity and amenity. Design and Construction Guidance, published by Water UK, clarifies in Part C the components of Sustainable Drainage Systems which can be adopted by Sewerage Undertakers. We will consider adoption of a wider variety of SuDS components including swales, ponds, rills and soakaways, if built to adoptable standards.

We do not adopt balancing ponds, culverted watercourses or rhynes, only the headwall(s) into them.

For further information and our SuDS policy please see <u>Sector guidance on sewerage and</u> water adoption agreements on our website.

7.6 Surety or deposit payments

Where we adopt new assets under section 104, we will require a surety or deposit.

- The surety has to be made with an appropriate body (e.g. National Housing Building Council), the determination of which is a matter for the customer and the appropriate body. On adoption of the assets, we will confirm that the surety can be released.
- The deposit will be based on our estimated construction cost, or a minimum of £5,000. We will calculate interest on the deposit from the date that the agreement between us and the customer is signed, until the date that the assets are adopted. We will return the deposit and interest payable to the customer once the assets have been adopted. The calculation of interest will be consistent with Ofwat's guidance on this.

7.7 Our charges – diversion of existing sewers

If there are sewers crossing a new development site and the layout cannot be designed to avoid them, they must be diverted if technically possible. You can propose a scheme and ask us to consider whether a diversion is possible.

We define three types of sewer diversion, shown in the table below.

7.7.1 What charges are payable?

For major and minor diversions, any suitable contractor can undertake the diversion work for you, since this work is contestable, but you will need to pay our administrative and application charges and a returnable cash deposit/bond (as long as the work is completed to the appropriate standard).

Table 7-5 shows our non-contestable charges and these will apply where works are simple in nature. Please refer to section 2.1.7 for exceptions to using our upfront diversion charges and to section 2.1.8 for the stage gate process we would use where in instances where using upfront diversion charges is not appropriate.

Our charges for sewer buildovers are included in our technical guidance documents.

8. Water and sewerage infrastructure charges (s146)

8.1 What is an infrastructure charge?

Infrastructure charges are used to cover the cost of improving our existing network to cope with providing extra capacity for new developments. An infrastructure charge is payable by anyone who wishes to build or develop a property.

8.2 Do you need to pay an infrastructure charge?

You will be required to pay the infrastructure charge if you:

- build new premises, including houses, flats, commercial premises, institutions, permanent caravans that are subsequently connected to our network;
- convert existing premises such as a house into flats and thereby increase the number of connections required; or
- connect existing premises to our network for the first time.

The charge is payable for each new connection made. Where you already had a connection in place, we will take that into account in assessing the charge payable.

8.3 What work is required?

Demand from a new development can affect the performance of the existing infrastructure to an extent where reinforcement of the network (e.g. by construction of new mains, tanks, sewers, service reservoirs, pumping stations) is required to maintain service levels to customers. The infrastructure charge will be used to fund network modelling and capital investment to ensure that new developments are able to connect to our water and sewerage network with no deterioration of service for new or existing customers.

We are responsible for undertaking the work required to increase the capacity of our network. Network reinforcement work is non-contestable.

8.4 Our charges – network reinforcement

Our water and sewerage networks are complex and we have invested heavily in network reinforcement to anticipate new developments. We liaise with local authorities and new connection services' customers to understand their requirements and to ensure that our network has sufficient capacity to allow new developments. Our gross infrastructure charges will recover the cost of network reinforcement required for new development.

Our infrastructure charges for 2025-26 are based on the forecast cost of upstream and downstream network reinforcement across our region over the next five years (developed as part of our PR24 business planning). Upstream and downstream infrastructure investment to provide capacity is, by its nature, very long-term and can vary significantly year-on-year. We have therefore set our infrastructure charges so as to recover our forecast costs over the next five year period, based on a linear profile of increases across the next five years to 2030. This results in a smooth profile of charges over time, and avoids large changes in charges (both upwards and downwards, and between supply and sewerage charges) that would occur if

charges were set annually to mirror the forecast profile of network reinforcement investment. All other things equal, this results in a lower overall increase in combined supply and waste connection charges for 2025-26, compared to setting charges to recover in-year costs.

We set out our calculation of infrastructure charges for 2025-26 and our 5 year forecast of network reinforcement costs in the table below. As the income offset no longer applies from 1 April 2025 (see Section 2.2 for details), infrastructure charges are no longer adjusted for this and they are set to recover full network reinforcement costs. However, customers are eligible for discounts (known as environmental incentives) to both supply and sewerage charges where they commit to building new homes that are more water efficient and with sustainable drainage. This is explained in Section 8.5.1 below.

8.4.1 Water supply infrastructure charge

We will set an infrastructure charge of £252 for 2025-26.

We forecast this charge will increase over the rest of AMP8 on a broadly linear profile, in order to recover our total network reinforcement costs across our region over the next five years.

8.4.2 Sewerage infrastructure charges

We set two infrastructure charge rates for sewerage connections, reflecting the specific circumstances of the development. Specifically:

• for connections where the development includes some form of SuDS scheme that attenuates the flow of surface water into our existing or proposed network.

• for developments with no surface water abatement, reflecting costs related to additional wastewater drainage and treatment.

On this basis, we will set a gross infrastructure charge of £1,004 for 2025-26 for sewerage connections with zero surface water abatement, and a charge of £502 for connections where the development included some form of SuDS scheme that attenuates the flow of surface water into our existing or proposed network.

We forecast these charges will increase over the rest of AMP8 on a broadly linear profile, in order to recover our total network reinforcement costs across our region over the next five years.

8.5 What charges are payable?

Table 8-1 and Table 8-2 show our infrastructure charges. Where you are building on a site that has previously been connected to our network, an infrastructure credit may be available. Where you are building non-standard properties, you will need to calculate the relevant multiplier. Sections 8.6.2 and 8.6.3 contain more information about these.

8.5.1 Environmental incentive and component

We offer discounts (known as environmental incentives') to both supply and sewerage charges where customers commit to building new homes that are more water efficient and with sustainable drainage. These incentives are funded through an environmental component, which is included in the calculation and presentation of our infrastructure charges. The environmental component has been determined in accordance with the principle that the total cost of offering the environmental incentive is broadly equivalent to the total revenue received from the environmental component within the infrastructure charges. This ensures that costs continue to be recovered in full.

The environmental incentive and component for water and sewerage connections are described below. They have been set in accordance with Ofwat's charging rules and Environmental Incentives Common Framework.

Water connections

The environmental incentive is a £100 credit on the full water infrastructure charge that is available for those customers who provide evidence that a new property will consume less than 100 litres per person per day. Further details of this qualifying criteria and the application process to claim this credit are published on our website⁷.

The size of the credit has been set based on the estimated per household cost savings (in terms of avoided supply-side schemes that would otherwise be required to maintain a supply demand balance) resulting from a reduction in consumption from 110 litres per day (as per current Building Regulations) to an assumed level of 95 litres per day.

The environmental component that funds this incentive is roughly £2.50 per dwelling. This is calculated based on expected take-up of the incentive for 2025-26 of 2.5% of new supply connections (which is informed by take-up of the incentive scheme in the current 2024-25 charging year). This implies a total expected cost for the incentive of around £12,000, or approximately an additional £2.50 per new connection to recover through the infrastructure charge. This component is included in our infrastructure charge of £252.

Sewerage connections

The environmental incentive is available for those customers who commit to zero surface water discharge into our existing or proposed network, giving the dual outcome of benefitting the environment and lowering the charge paid. This credit lowers the infrastructure charge to 10% of the gross charge for connections where no surface water abatement occurs. Customers that wish to claim the credit against the infrastructure charge will need to provide information on the applicable plots.

We have previously presented this as an alternative sewerage infrastructure charge that would be paid in such circumstances (i.e. where the new connection results in zero surface water

drainage). This year, reflecting Ofwat's Common Framework for Environmental Incentives, we are instead presenting the credit that would apply by claiming this environmental incentive. The level of credit presented in Table 8-2 is against the infrastructure charge that would be paid for connections that include an agreed SuDS scheme (applicable to most development sites, in order to obtain planning permission).

This change also ensures consistency of presentation with our water infrastructure charges and associated environmental incentive. This change has not affected the level of these charges.

The environmental component that funds this incentive is roughly £247 per new connection. This is calculated based on expected take-up of the incentive for 2025-26 of 50% of new sewerage connections (based on historic levels of take up of the lower charge). We have then estimated the infrastructure charges in a counterfactual scenario where this incentive is not offered and these connections instead paid the full charge for schemes with the inclusion of an agreed SuDS scheme. In this scenario, we estimate the weighted average infrastructure charge (across those developments with no surface water abatement and with the inclusion of a SuDS scheme) would be roughly £247 lower. The implicit environmental component that ensures the total cost of the environmental incentive is broadly equivalent to the additional revenue received is therefore £247 per dwelling.

8.5.2 Infrastructure charge credit

Infrastructure charge credits will be applied where the site has been connected to our network within the previous five years, to reflect the reduction in the need for network reinforcement.

The credit is applied by deducting the number of former dwellings connected on the site or by taking the metered consumption or discharge from the site and equating that to an average dwelling within our area to arrive at an equivalent number of dwellings. In the absence of metered information, other reasonable evidence should be used to estimate the prior demand on the network from the site.

8.5.3 The relevant multiplier

In certain circumstances where water is used for purposes other than flats or houses, as in commercial premises, schools, hotels etc, the infrastructure charge is calculated using the number and type of water fittings installed in the premises – known as the relevant multiplier (RM). The RM is calculated by adding up the loading units for all water fittings in the property and dividing by 24 (the total number of loading units for a standard dwelling). The RM is multiplied by the relevant water and sewerage infrastructure charge to arrive at the total charges for the property.

8.5.4 Loading units for calculating the RM

Table 8-3Table 8-1 sets out the loading units for non-standard properties.

- 6. Where premises have only a sewerage connection and there are no water fittings, the relevant multiplier will be one.

8.5.5 Using the relevant multiplier on a new development

Suppose that a new 20-bedroom hotel is built. Table 8-4 sets out its requirements and these are used to calculate the RM.

The final row of this table will be multiplied by the relevant infrastructure charge.

8.6 Upsizing new assets for future use

Where it is reasonable to do so, we may propose that assets provided by developers, NAVs or SLPs should be upsized to provide capacity for later growth. Where assets are upsized as a result of our request, we will contribute towards the reasonable cost. The contribution will be based on assumed flow rates for the development relative to that of the other flows allowed for in the design.

Upsizing new assets to allow for future use is considered to be network reinforcement and we will take account of this type of investment when setting our infrastructure charges.

8.7 Network enhancement

Network enhancement refers to the process of dealing with pre-existing shortfalls in capacity that are not the consequence of new development. The cost of addressing pre-existing shortfalls in capacity, greater demand from existing properties, enhancing the network's performance, or improving network flexibility may not be recovered through the infrastructure charge. Such enhancement is funded by income raised from water and sewerage bills.

Where we provide or require assets that are designed to include an element of network enhancement, we will ensure that charges are apportioned such that we fund the network enhancement element. This apportionment will be based on assumed flow rates for the development in relation to that of the other flows allowed for in the design.

8.8 Interaction with the planning system

Our infrastructure charges will ensure that the cost of providing network reinforcement is met by new connection services' customers and we can plan and execute works required. This planning and execution of works should mean that local planning authorities will no longer require assurance that we can serve particular developments, as long as the development does not progress at a rate which exceeds the time we need to provide capacity. In some circumstances, we may need to agree a phasing condition from the planning authority to protect customers and/or the environment.

We have agreed to comply with guidelines developed by Water UK.

Appendix B Prescribed Worked Examples

In all our scenarios, it is worth noting that:

- We do not have separate costs for using barrier pipes. Our charges reflect the average charge whether PE or barrier pipe. Our policy is that all service connections use barrier pipe and that all new mains use barrier pipe unless evidence of no contamination anywhere on site and confirmation of no permeable paving use is provided by the customer (see Section 5.1).
- We do not have separate costs for Administration and Application. We charge one combined fee inclusive of all relevant costs.
- We include the costs of a meter and its installation in our connection charge.
